## Specialist Data Security Speakers Out In Force To Inform and Protect Hampshire Businesses At Key Business Event

Speaking at the specially convened conference on Data Protection and cyber security were, Director of Technology, Security & Governance, **JP Norman**, along with **Adam Nash** of cloud based end point security specialists Webroot and **Paul Marsh**, Director of penetration testing specialists, SecQuest.

Keynote Data Protection speaker **JP Norman** said: "Not enough businesses have started their preparations for the impact of the EU General Data Protection Regulations on  $25^{th}$  May 2018. The new responsibilities around data management, security measures and penalties arising from non compliance will potentially wipe out businesses who fail to act. The fines from May 2018 will be up to 4% of global turnover or a maximum fine of  $\leq$ 20 million. In addition, companies could be fined up to £500,000 by the UK's Information Commissioner's Office, as well as individuals' rights to pursue lawsuits against company directors.

The Information Commissioner's Office is committed to helping UK businesses and public bodies to prepare to the meet the requirements for GPDR. It has published a <u>12 point plan</u> and we urge all organisations to review it against their current data protection measures".
